Sacramento's Literacy Month

During the month of September, we participated in four book giveaways and distributed 700 bags or 3,500 books to TK-2nd grade students. This is less than last year, unfortunately, and something we hope to remedy next year.

We concluded Literacy Month with our Literacy Festival in collaboration with the Food Literacy Center's Oak Park Farmers Market. Twenty literacy focused organizations set up booths with activities and information for kids and parents. Many families from the neighboring community came out to enjoy the festival activities. Festival goers danced to Clean Slate, a live band performing old school Rhythm and Blues, and every child received at least one free book. The festival was appreciated by everyone! ■

Elk Grove Rotary Partnership

This Fall, the Rotary Club of Elk Grove is funding our culturally relevant book giveaway program at two Elk Grove Unified elementary schools.

We are thrilled to align our missions to give 740 TK-2nd grade students at Charles Mack and Samuel Kennedy Elementary Schools a bag of culturally relevant books. Mark Thomas, a member of the Rotary Club of Elk Grove says, "Our club members understand that literacy, especially in [under-resourced] schools, is a major issue impeding their students' future ability to succeed. So many under-resourced students are without books at home to help continue to improve reading skills; whereas more affluent students have these resources."

One of the Rotary's focus areas of work is literacy, and our program is a great way to support positive literacy outcomes. In addition to financial support, Elk Grove Rotary club members volunteer during book giveaways to handbooks to the students. ■



ADVOCACY UPDATE:

Science of Reading Legislation (AB 1454) Passes with Unanimous Vote!

Both houses of the California Legislature voted unanimously for AB 1454 and appropriated \$200M for teacher training and another allocation to develop instructional materials.

Governor Newsom signed the hard-earned legislation on October 9, 2025. This makes California the 11th State to pass comprehensive literacy legislation. In 2023, we passed Reading Instruction legislation which directs higher education institutions to teach future teachers how to teach the Science of Reading and we passed the Early Screener legislation to help detect reading difficulties in kindergarten, 1st and 2nd grades.

We have legislation, now we need implementation:



End of Year Giving Ideas

With the year-end upon us, you may be thinking about your contribution allocations, and we hope you are considering a gift to the Sacramento Literacy Foundation. No matter where you extend your philanthropy, here are a couple of factors you may not have considered:

Giving Appreciated Stock

You can make a gift of appreciated stock and avoid the capital gains taxes you would otherwise pay if you sold the stock.

Giving Directly from your Retirement Plan

Giving directly from your IRA or qualified retirement fund is a great way to reduce your tax burden. If you are age 73 or older, you are obligated to make annual Required Minimum Distributions (RMDs) from your retirement fund. To avoid

being taxed on those distributions, funds need to be transferred directly from your IRA custodian to the nonprofit; they cannot first pass through your hands. Check your IRA custodian's website for instructions on how to initiate a QCD.
