

5TH ANNUAL COMMUNITY LITERACY MAP

The purpose of the Sacramento County Community Literacy Map is to illustrate Sacramento County's progress on key literacy indicators over time and then identify where literacy resources and interventions are needed most in Sacramento County. This year we have broadened our base-line data to include Sacramento County's affordable and public housing sites and all of California's elementary schools.

MEASURING THE COVID SLIDE

COVID-19 was projected to reduce reading proficiency by 10%-20% -- did it? The data for the 2021-2022 school year shows that California's reading proficiency went down by 6.5%, and that Sacramento County's reading proficiency went down by 6.6%.

What makes the data hard to understand is the dramatic increase in truancy rates which occurred all throughout California due to COVID. California experienced a 2.5 times increase in truancy rates between the 2018-19 and 2021-22 school years and Sacramento County experienced a 2.4 times increase in truancy during the same period.

A cursory review of 16 of the 20 elementary schools in the Promise Zone shows that approximately 22% fewer third graders took the standardized language assessment in 2021-22 than in 2018-19. Without having more specific data on population increases and decreases, we cannot measure the exact impact COVID-19 had on reading rates, however, it seems likely that reading proficiency decreased 10%-30%.

PRESCHOOL ENROLLMENT **IS DOWN**

Between 2016 and 2021, preschool enrollment in Sacramento County has decreased by 31%. The three top reasons children fall behind in reading are: not reading in the summer, truancy, and kindergarten readiness which primarily happens in preschool. With truancy rates at an all-time high and preschool enrollment at an all-time low, the job of teaching all kids to read at grade-level has become more difficult than ever.

COVID-19'S SILVER LINING

When trying to solve big problems, it's important to find the silver lining. So, while it's true, COVID-19 has had a huge negative impact on our nation's student population, it also created increased awareness and advocacy around our country's current reading crisis.

Prior to COVID, most people were not aware that more kids were below grade-level reading than were above grade-level reading. We did not know how deeply our education system was failing to teach reading. Emily Hanford's podcast Sold a Story: How Teaching Kids to Read Went So Wrong has caught the attention of parents, educators, and advocates alike. LeVar Burton recently executive produced The Right to Read, an important documentary showing how the education system is failing children from all income levels. The reading deficits our kids have been living with have been put in the spotlight. Now we know.



SACRAMENTO ALL-AMERICA CITY AWARD 2022



Sacramento The National Civic League and the Campaign for Grade-Level Reading have named Sacramento as one of ten city winners in its annual All-America City Award for our unique public-private collaboration aimed at improving student literacy in Sacramento's Promise Zone. Since 1949, the All-America City Award has been given to the top ten communities across the U.S. that are leveraging civic engagement, collaboration, inclusiveness, and innovation to address local issues. Spearheaded by the Sacramento Literacy Foundation and the Sacramento Promise Zone, and directed by Sacramento Housing and Redevelopment Agency (SHRA), Sacramento's nationally recognized project – the Promise Zone Literacy Initiative – is aimed at bringing

literacy interventions to the community with one-to-one early reader tutoring, summer reading programming to affordable housing communities, a GIS mapping tool that shows literacy rates at each public school, and more. The goal of the project is to have all children in the Promise Zone reading at grade-level. Post-pandemic, only 38% of 3rd grade students in Sacramento County were at grade-level reading and only 27% were at grade-level in the Promise Zone, an example of the disproportionate negative impact on historically marginalized communities. We are now leveraging the All-America City recognition into more resources for the Sacramento Community. Stay tuned.




LITERACY INDICATORS | TRENDS


EARLY CHILDHOOD EDUCATION

Percent of children ages 3-4 enrolled in preschool.




CHRONIC ABSENCE



DEFINITIONS OF LITERACY INDICATORS & SOURCES

Early Childhood Education: The percent of children ages three to four who are enrolled in school (i.e., nursery school, preschool). Source: US Census Bureau, American Community Survey, 1-Year Estimates, Table S1401: School Enrollment https://data.census.gov/cedsci/

Chronic Absence: Chronic absenteeism rate. Students are determined to be chronically absent if they were enrolled for a total of 30 days or more at the selected reporting level during the academic year and they were absent for 10% or more of the days they were expected to attend. CDE began tracking this data in 2016/17. Source: California Department of Education, DataQuest https://dq.cde.ca.gov/dataquest/

Note: Chronic Absenteeism replaced Truancy as a measure of school attendance in 2016. Truancy is no longer reported in DataQuest.

English Language Arts (ELA) Proficiency | 3rd Grade/All Grades: California Assessment of Student Performance and Progress (CAASPP) outcomes are reported in terms of four levels of achievement: Level 1 (standard not met), Level 2 (standard nearly met), Level 3 (standard met), and Level 4 (standard exceeded). These correspond to a set of achievement level descriptors that are aligned with the Common Core State Standards (CCSS) and the Smarter Balanced assessment. Based on their CAASPP scaled scores, students fall into one of the four categories of performance. Students performing at Level 3 (standard met) and Level 4 (standard exceeded) are considered on track to demonstrating the knowledge and skills necessary for college and career readiness.
