THROUGH THE WALK4LITERACY AND THE COMMUNITY LITERACY MAP, THE FOUNDATION PARTNERED WITH 18 CHILDREN'S LITERACY ORGANIZATIONS TO ADVANCE THE AWARENESS AND INCREASE THE FUNDING OF LITERACY PROGRAMS. THE FOUNDATION SECURED CORPORATE FUNDERS TO MAINTAIN THE COMMUNITY LITERACY MAP WHICH SHOWS EXACTLY WHERE CHILDREN ARE REACHING GRADE-LEVEL READING AND WHERE THEY ARE NOT. THE BIG DAY OF GIVING IS A COMMUNITY ACTIVITY TO GROW COMMUNITY SUPPORT. THE FOUNDATION BECAME THE COMMUNITY CONVENER FOR THE NATIONAL CAMPAIGN FOR GRADE-LEVEL IN 2019 AND IS DEEPENING ITS ROLE AS CONVENER EVERY DAY. A BROADER LITERACY MOVEMENT IS DEVELOPING IN SACRAMENTO AND IN JULY 2022, THE FOUNDATION PARTNERED WITH THE SACRAMENTO HOUSING AND REDEVELOPMENT AGENCY AND LED THE LITERACY COMMUNITY TO WIN SACRAMENTO AN ALL-AMERICAN CITY AWARD, 2022.

THIS YEAR, THE FOUNDATION GAVE A TOTAL OF \$290,265.67 DIRECTLY TO THE COMMUNITY REPRESENTING \$52,146 DISTRIBUTED FROM THE CHILDREN'S LITERACY ENDOWMENT, \$135,980 IN DIRECT SUPPORT OF THE PROMISE ZONE LITERACY INITIATIVE AND \$8,720 UPDATING THE COMMUNITY LITERACY MAP.
